

FTA DRUG AND ALCOHOL AUDIT

Eight of the consortium members have recently been audited by FTA auditors for their drug and alcohol testing program. The audit fieldwork was conducted on-site the week of July 6th, 2015. The audit included interviews with members' DERs, Medical Review Officer, Substance Abuse Professional, and Collection Technicians, as well as drug and alcohol record's review, and collection site visits. This is the third audit of the statewide drug and alcohol testing consortium operations (2004, 2009, and 2015), and improvements have resulted from each audit. Overall, the auditors were satisfied with the level of professional knowledge and expertise revealed by the DERs and staff of the eight audited members, and by the consortium personnel.
