The CT Statewide drug and alcohol testing results for calendar year 2015 have been submitted to FTA's Office of Transit Safety and Oversight in early March 2016.

Please note that effective June 25, 2013, the FTA Administrator has the discretionary authority to bar a recipient from receiving Federal transit funds should the recipient fail to comply with the requirements of 49 CFR Part 655 – the regulation includes this reporting requirement.

Thanks to ODT and Consortium DERs for their diligence in verifying and finalizing the 2015 test results.

Once the policies have been finalized, they will be sent to DERs for adoption by the consortium member's governing body.

Random Testing Requirement

Reminder:

Random tests whether conducted on-site or at the collection site include **both alcohol and drug**. **Alcohol is required to be tested first**.

Recent inquiries from consortium members regarding record retention period requirements and the types of records to maintain have prompted us to remind you of these important FTA regulations (specifics can be found at 49 CFR 655 Subpart H - Administrative Requirements §655.71 Retention of records.) For your reference a summary of these regulations is as follows:

Record Retention Period

Number of Years	Documentation	
One	 Negative drug or alcohol test results 	
Two	Records related to the collection processEmployee training records	
Five	 Verified positive drug or alcohol test results Documentation of refusals Employee referrals to the Substance Abuse Professional (SAP) Annual Management Information System (MIS) Reports 	

Maintenance of Records

• Records related to the collection process:

- ➤ Documents related to the random selection process
- ➤ Reasonable suspicion and post-accident testing determination documentation
- ➤ Medical Review Officer (MRO) documents related to valid medical explanation for shy lung/bladder

• Records related to test results:

- > Employer's copy of the custody and control form
- ➤ Refusal to submit Documentation
- > Covered employee disputing test result documentation
- ➤ SAP referral, return to duty, and follow-up testing documentation

• Records related to employee training:

- > Drug use awareness and alcohol misuse training materials
- ➤ Employer's drug and alcohol testing policy
- ➤ Covered employees' training records including attendee names, dates, and times
- > Supervisor reasonable suspicion training documentation
- ➤ Annual MIS Reports
